We seek an experienced member for our team, a Research Associate, with strong background in European Research Projects. The candidate will participate in the R&D activities of FORTH in the context of the projects “CERTCOOP: Trans-European and Greek CERTs collaboration project. Funded by the European Commission (CEF-2016-3)” and “Smart End-to-end Massive IoT Interoperability, Connectivity and Security - SEMIoTICS, funded under Horizon 2020, H2020-IoT-03-2017”.

In the context of the above mentioned projects, FORTH, along with the project’s partners, will integrate their cybersecurity solutions to existing platforms (e.g. CSP platform) and ensure the interoperability and the secure exchange of the data. The SEMIoTICS framework will support cross-layer intelligent dynamic adaptation, including heterogeneous smart objects, networks and clouds, addressing effective adaptation and autonomic behaviour at field (edge) and infrastructure (backend) layers based on intelligent analysis and learning.
