We seek one (1) student member to join our team, at the postgraduate level in the field of Computer Engineering, preferably with background in Distributed Computing Systems, Operating Systems and Networks. The candidate will participate in the R&D activities of FORTH in the context of the project “SMESEC: Protecting Small and Medium-sized Enterprises digital technology through and innovative

cyber-SECurity framework". In the context of SMESEC project, FORTH, along with the project's partners, will study and develop security mechanisms for ICT enabled systems. The SMESEC framework will enable SMEs to enhance their security capabilities by introducing an innovative low cost security framework that extends current security solutions providing full coverage and security training capabilities.

- PhD candidate in Computer Science or a related field.
- Experience in web applications development (security and privacy) and systems programming
