Description

We seek one experienced members for our team, and specifically a MSc holder in Computer Science & Informatics, with background in European RTD Projects. The candidate will participate in the R&D activities of FORTH-ICS in the context of the H2020 project “Mingei – Representation and Preservation of Heritage Crafts”, funded under Horizon 2020, SC6-TRANSFORMATIONS-2018-2019- 2020 and will work on its Conceptual Modeling, Design and Development of Semantic Applications and Services related aspects.

Mingei is coordinated by FORTH-ICS, who is also the Technical Coordinator of the project. The project will explore the possibilities of representing and making accessible both tangible and intangible aspects of craft as cultural heritage. Heritage Crafts (HCs) involve craft artefacts, materials, and tools and encompass craftsmanship as a form of Intangible Cultural Heritage. Intangible HC dimensions include dexterity, know-how, and skilled use of tools, as well as, tradition, and identity of the communities in which they are, or were, practiced. Mingei will provide the means to establish HC representations that will capture and preserve tangible and intangible dimensions based on digital assets, semantics, existing literature and repositories, as well as mature digitization and human-centric AR and VR representation technologies.

- MSc on Computer Science & Informatics
- At least 5 years of demonstrated experience with ICT R&D projects
- At least 5 years of demonstrated experience in Conceptual Modeling
