The candidate will participate in the R&D activities of FORTH in the context of the project "SPIDER A cyberSecurity Platform for vIrtualised 5G cybEr Range services". In the context of the SPIDER project, FORTH, along with the project's partners, will examine and propose solutions to enable trust in computations and systems security. As such, prior experience in systems security are very important aspects for the position offered.
