The candidate will participate in the R&D activities of FORTH in the context of the project EPI: “European Processor Initiative”. The EPI SGA project will be the first phase of the European Processor Initiative Framework Partnership Agreement, whose aim is to design and implement a roadmap for a new family of low-power European processors for extreme scale computing, high-performance Big-Data and a range of emerging applications.

Requirements:

- Enrollment to a University Graduate Program in Computer Science or Computer Engineering.
- Physical presence at FORTH, Heraklion, Crete for the duration of the position.
- Willingness and ability to work cooperatively within a team, to learn, and to adapt to the projects.
- Names of at least two professional references
- Fluent knowledge of English.

- Computing systems, performance analysis, experience with ARMv8 and RISC-V architectures and system components.
