The candidate will participate in the R&D work of FORTH within the Panacea project. We are looking for an experienced postdoctoral researcher to be part of the team designing and implementing a system integrating the technological toolkits of the PANACEA project, namely a dynamic risk assessment & mitigation tool, a secure information sharing tool for the protection of data, a security-by-design & certification tool, and a tool for identification & authentication. The candidate will be also

involved in performing dynamic analysis of cybersecurity frameworks in EU healthcare, as well as iris based biometric solutions.

- PhD in Biomedical Engineering/Informatics.
