Description

We seek one (1) experienced system software engineer for our team, with background in European Research Projects. The candidate will participate in the R&D activities of FORTH in the context of the project DEEP-SEA: "DEEP – SOFTWARE FOR EXASCALE ARCHITECTURES". The EuroHPC Research & Innovation project DEEP-SEA starts in April 2021 and will last for 3 years. It aims at improving software support for highly heterogeneous systems, which combine different processing units and diverse memory technologies. DEEP-SEA adopts the modular supercomputing architecture (MSA), and considers heterogeneity and performance at both the node level and at the system cluster level. Composability, programmability, portability, malleability, and reliability are targeted with a comprehensive system software and programming environment, which combines traditional models (MPI, OpenMP, OmpSs, GASPI) with higher-level, hardware-agnostic approaches (NabLab, DaCe).

Required qualifications:

- Diploma in Computer Science or Computer Engineering
- Demonstrated experience with C, C++, and Python programming languages
- Demonstrated experience with applications that require high performance and low latency
- Demonstrated experience with system prototyping, validation and performance evaluation
- Demonstrated experience in EU-funded project activities
- Physical presence at FORTH, Heraklion, Crete for the duration of the position
- Fluency in English
- Names of at least three professional references

Desired qualifications:

- Experience with resource management of Linux-based HPC clusters
- Experience with parallel applications based on MPI, OpenMP, and GPU-based accelerators
