We seek for an experienced member for our team with a strong research background in Computer Science. The candidate will participate in the R&D and Management activities of FORTH in the context of the project “SESAME: Secure and Safe Multi-Robot Systems, funded under H2020-ICT-2018-20”.

The candidate will participate in the development of novel robot-specific methods for threat modelling and vulnerability assessment of Multi Robot Systems (MRS) missions supporting the identification of security hazards and the enactment of potential countermeasures while also considering potential safety implications.
