The candidate will participate in the R&D activities of FORTH in the context of the project “COllaborative Platform for trAnsmedia storytelling and cross channel distribution of EUROPEan sport events” (COPA EUROPE), funded under Horizon 2020, ICT-44-2020 - Next Generation Media.

COPA EUROPE is coordinated by Worldline Iberia and FORTH-ICS is a member of the project consortium. The project aims to address the exploding demand for non-linear sports consumption (live and eSports) by leveraging Over The Top streaming and combining it with new set of media technologies that will democratise the consumer experience, enable cost-sensitive live video from anywhere, and personalize the distribution to change the experience of each viewer individually.
