The candidate will participate in the R&D work of FORTH within the Panacea project. We are looking for an experienced developer to be part of the team designing and implementing a system integrating the final toolkits of the PANACEA project, namely a dynamic risk assessment & mitigation tool, a secure information sharing tool for the protection of data, a security-by-design & certification tool, and a tool for identification & authentication. The candidate will be mainly involved in the adaptation and

integration of an iris based biometric solution as part of a cybersecurity framework implemented in the project.
