We seek one (1) student enrolled to a University MSc Program to become a member for our team. The candidate will participate in the R&D activities of FORTH in the context of the project EVOLVE: HPC and Cloud Enhanced Testbed for Extracting Value from Large-scale Diverse Data. The EVOLVE project is a pan European Innovation Action introducing important elements of High-Performance Computing (HPC) and Cloud in Big Data platforms taking advantage of recent technological advancements to allow existing and emerging applications to keep up with the unprecedented data growth we are experiencing. EVOLVE aims to build a large-scale testbed by integrating technology from the HPC, Big Data, and Cloud worlds.

Required qualifications:

- Enrollment to a University MSc Program related to Bioinformatics.
- Fluent knowledge of English.
- Physical presence at FORTH, Heraklion, Crete for the duration of the position.
- Willingness and ability to work cooperatively within a team, to learn, and to adapt to the projects.
