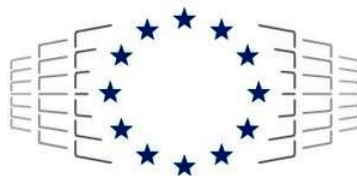

**Description**

We seek two (2) Hardware & RTL Design and Test Engineers for our team, with background in European Research Projects. The candidates will participate in the R&D activities of FORTH in the context of the project RED-SEA: "Network Solution for Exascale Architectures". The EuroHPC Research & Innovation project RED-SEA starts in April 2021 and will last for 3 years. The next generation of Exascale systems will critically require an efficient network, that will support massively parallel processing systems (hundreds of thousands of nodes, millions of cores), provide a set of features allowing applications to scale efficiently at Exascale level and beyond, be prepared for power-efficient accelerators and compute units, and support wide-spread and emerging datacentric and AI-related applications. The RED-SEA consortium pursues this target, leveraging key European competences & background, including BXI, the key production-proven European Interconnect, as well as results from a number of EU-funded projects on interconnects and HPC systems.

**Required qualifications:**

- University Degree in Science or engineering.
- At least 3 years of experience in related roles after the BSc degree (can be a mixture of work and/ or graduate studies in related topics).
- Names of at least three professional references.
- Physical presence at FORTH, Heraklion, Crete for the duration of the position.
- Fluent knowledge of English.
- Demonstrated experience with hardware description languages, Verilog, System Verilog.
- Demonstrated experience with Xilinx tools (Vivado chipscope, etc) and integration for FPGA SoCs
- Demonstrated experience in advanced digital design, particularly in network-level RDMA-based protocols and network interfaces.
- Demonstrated experience with EU-funded projects activities..

- Experience with test-driven development and validation of hardware and software blocks
