Description

We seek one (1) experienced project manager with background in European Research Projects. The candidate will contribute to the coordination and management of R&D activities of FORTH-ICS, in a full-time (preferred) or part-time capacity, particularly in the context of the project DEEP-SEA: "DEEP – SOFTWARE FOR EXASCALE ARCHITECTURES". The 3-year Research & Innovation project DEEP-SEA starts in April 2021, and is co-funded by the European High Performance Computing Joint Undertaking (EuroHPC JU) and the Greek General Secretariat for Research and Innovation. It aims at improving software support for highly heterogeneous systems, which combine different processing units and diverse memory technologies. DEEP-SEA adopts the modular supercomputing architecture (MSA), and considers heterogeneity and performance at both the node level and at the system cluster level. Composability, programmability, portability, malleability, and reliability are targeted with a comprehensive system software and programming environment, which combines traditional models (MPI, OpenMP, ompSs, GASPI) with higher-level, hardware-agnostic approaches (NabLab, DaCe).

Requirements

- Diploma, or higher academic title, preferably in a Science or Engineering discipline
- Demonstrated experience in supporting the execution of EU-funded and nationally-funded research and innovation projects in the domain information and communication technologies, including managing deliverables, financial reporting, organization of project meeting, tracking

of tasks, procedures for procuring equipment, and similar project-management related tasks and activities.

- Demonstrated experience with the process of preparing grant applications (both EU-level and national)
- Physical presence at FORTH, Heraklion, Crete for the duration of the position
- Fluency in English
- Names of at least three professional references
